Directors & Officers

Financial Products (cont'd.)

Bankers Blanket Bond (BBB)

Protects against direct financial loss resulting from employee infidelity, physical loss of property on premises and in transit and forgery/alteration of monetary instruments and other valuable documents.

Professional Indemnity

Financial protection against liability for financial loss to a third party, caused by a negative act, error or omission by the organization's officers or employees.

Electronic Computer Crime

Provides protection against loss incurred by the bank due to the theft of electronic data and fraudulent funds transfers resulting from hacking or other fraudulent, illegal, or unauthorized entry into the bank's computer systems.

Cyber Liability

Covers losses from damage to, or loss of information from, IT systems and networks. Policies include significant assistance with management of the incident itself.

Trade Credit Insurance

Protects your receivables and balance sheet with the proper credit insurance while offering buyers attractive terms.

Credit Life/Credit Shield

Pays the lender (e.g. the Bank) if a borrower dies or becomes permanently disabled before repaying a loan in full. This could apply to a Bank's mortgages or outstanding credit card balances.

Financial Crime Risk Assessment

A Financial Crimes Risk Assessment (FCRA) is the cornerstone of effective financial crime prevention and includes the identification, quantification and documentation of the financial crime risks for your business as well as creating a framework for their management.
