## **THE COVER**

Our facility binder covers virtually all of the exposures that can befall a yacht including the following:

### **PROPERTY DAMAGE**

Hull and Materials, Engines & Machinery, Electrical and Navigational Equipment, Fixtures and Fittings, Tenders & Equipment.

### **MACHINERY DAMAGE**

Includes the *Machinery Damage Extension Clause (MDEC)*, which broadens the cover afforded by the policy towards the engine(s) of the vessel.

### **PERSONAL EFFECTS**

Covers the personal effects of passengers for up to USD 50,000 with a limit of USD 10,000 any single article.

### **THIRD PARTIES**

Covers damage to third party property and loss of life or personal injury to third parties including passengers. Water Skier's Liability covered up to USD 1,000,000. Legal costs are also covered.

### **MEDICAL EXPENSES**

Covers doctors' or surgeons' fees up to USD 10,000/- any one accident for injuries sustained by passengers as sustained by passengers as a direct result of the insured vessel sinking or being in a collision with another vessel or with any external object other than water.

### **CRUISING AREA**
