Jewelers Block

Covers loss or damage to jewelry, precious stones, and metals from theft, burglary, fire, and transit, whether on-premises, in a safe, or at exhibition. In an increasingly digital world, crypto-currencies, digital art, and the emerging asset class of non-fungible tokens (FTs) also can be added to this list. So can luxury brands, which continue to experience increases in sales.

Cancellation & Abandonment

Cancellation insurance is designed to cover the financial losses you incur when the event named in the contract is canceled, postponed, suspended, shortened or moved due to the occurrence of an event beyond your control, not excluded by the contract, and making it impossible to maintain or run the insured event.

Bloodstock

Thoroughbred show horse insurance policy provides cover for high quality and value horses worldwide against equine mortality resulting from an accident, illness, injury or disease.

Livestock

Livestock insurance protects farmers and ranchers from financial losses due to the death, theft, or illness of animals, including cattle, poultry, and pigs. Commonly covers mortality from accidents, disease, and natural disasters, as well as transit risks and business interruption.

Agriculture

Agricultural insurance protects farmers and agribusinesses against financial losses from natural disasters (drought, flood, hail), pests, diseases, and market price declines, ensuring operational continuity.

Precious Metals and Bullion

Coverage for luxury, exotic, or classic cars can offer higher liability limits, agreed-value coverage, and tailored protection that standard policies lack.

From small-scale shellfish farms to large offshore finfish operations, aquaculture businesses face a wide range of challenges — including natural disasters, disease outbreaks, stock mortality, and equipment breakdown. This cover can be designed to protect the unique risks faced by fish farms, hatcheries, and marine agriculture operations.
